Applicant shall provide financial statements to Creditor upon written request, and all such financial statements shall be kept strictly confidential by Creditor. Applicant's signature attests financial responsibility, ability and willingness to pay Creditor invoices in accordance with the terms stated on each invoice. Unless otherwise states on an invoice, payment terms will be Net 30. It is agreed and understood that the Applicant will be responsible to notify the Creditor if there are any changes in the Applicant's ability to pay. Signing this Credit Agreement, or directing Creditor to start work or order materials on Applicant's behalf constitutes an acceptance of Creditor's General Terms and Conditions of Sale, a copy of which can be found at <https://shop.gogcg.com/terms-and-conditions> ("Terms and Conditions"). The Terms and Conditions shall govern each transaction between the Applicant and Creditor. Failure to review the Terms and Conditions is not considered a waiver of the provisions contained therein. This Credit Agreement is expressly limited to full acceptance of the Terms and Conditions, and any term or condition stated by Applicant in any prior or subsequent proposal, purchase order, or in acknowledging or otherwise accepting a quote or any agreement or understanding modifying the Terms and Conditions shall not become binding upon Creditor unless specifically accepted in writing by Creditor. The Terms and Conditions prevail over any of Applicant's general terms and conditions of purchase regardless of whether or when Applicant has submitted a purchase order or such terms. A late payment charge equal to the maximum amount allowable under the applicable state's law, not to exceed 1.5% per month may be imposed on delinquent invoices. In the event the Applicant's account becomes delinquent, the Applicant waives the right to a jury trial and agrees to pay all collection costs and fees, including reasonable attorney's fees. All matters arising out of or relating to this Credit Agreement are governed by and construed in accordance with the internal laws of the State of Illinois without giving effect to any choice or conflict of law provision or rule. Any legal suit, action or proceeding arising out of or relating to this Credit Agreement shall be instituted in the federal courts of the United States of America or the courts of the State of Illinois in each case located in the City of Chicago and County of Cook, and each party irrevocably submits to the exclusive jurisdiction of such courts in any such suit, action or proceeding.
